Park District fails on promises to Berger Park

The squeaky wheel gets a dab of grease

In a set of extraordinary coincidences, Berger Park was the scene of frenetic activity Tuesday morning, June 25. After Chicago Park District (CPD) representatives failed to show for a previously scheduled meeting, a firm demand from 49th Ward Ald. Moore seemed to get results. Persistent complaints, letters and finally a petition from the Berger Park Advisory Council headed by President Lillian La Palio were probably additional factors that shook off the lethargy that has enfolded the CPD in a womb of inaction concerning the multiple problems at Berger Park.

Present for the 9am meeting in the infamous playlot (see articles on pages 5 & 7) were Ald. Joe Moore, Ms. La Palio, Lakefront Director Colleen Rock Mueller, North Lakefront Area Manager Dana L. Zilinski, CPD Community Outreach Manager Robert Steele, several assistants to the CPD representatives, Berger Park Supervisor Sue Nicotera and a dozen members of the Advisory Council.

The heat of the day was matched by the heat of the rhetoric as blame and excuses were traded. Ms. La Palio insisted that the playlot must be upgraded or replaced immediately as had been promised for years. Ms. Mueller stated that the CPD's new policy is to only match funds raised by the community for capital improvements. She also stated that it is park policy to remove any dangerous playlot equipment and not replace it until budgetary requirements are met.

While the combatants were engaged in this discussion, park employees were



removing a bench that had been broken over the weekend. The bench that was across from the Downey mansion coach house was one of seven that the Advisory Council had provided for the park at a cost of \$700 each. When hearing that the bench was to be removed and not replaced, Ms. La Palio's furious response to this injustice resulted in a promise that it would be replaced that day with a Park District bench.

Other Park District activity mysteriously coincided with the presence of this unprecedented meeting of local activists, Park District representatives and Ald. Moore. A CPD truck appeared, and workmen installed a new chess table and said another would be installed the next day. Other CPD workmen attacked the wood chip floor of the playlot, filling in bald spots. A pair of vendor carpenters appeared to take pictures and assess the wood rot and other damage that the coach house has suffered over the years. It is amazing how much incidental activity the CPD can generate when push comes to shove. However, this smoke screen of activity did not deter Ms. La Palio from her primary objective, the refurbishing of the playlot.

She and members of the Advisory

Council met later with Mr. Steele to prepare a laundry list of repairs and the plan for long-term financing of a new playlot. The estimate of construction of a new playlot ranged from \$300,000 to \$500,000. The CPD policy is to match locally raised funds, which would make the community-raised goal \$150,000 to \$250,000. Ms. La Palio is adamant that this magnitude of fundraising is impossible. Ald. Moore stated that he would attempt to find some funding, but recommended that the council work with Mr. Steele, who has the qualifications and resources to assist communities in raising these types of funds.

MECA board meeting

MECA board meeting Tuesday, June 25

Attendance: 11 board members, 2 management representatives and 16 residents. Not present: Ila Chaiken

OPEN FORUM 1

Resident comments and questions:

- When will the freight elevator numbers be installed? Will be finished by Monday
- Passenger elevators not working right last week. Nos. 2 & 3 were serviced last week. Please report any problems and the elevator number immediately to management.
- A resident presented an advertisement offering elevator camera coverage at a reasonable price.
- 4) Could we replace the glass in the CU entrance door with plastic? It is getting broken twice a year. *Management will look into it.*
- 5) Why isn't my (B-tier) balcony membrane being applied; everything else is done. Because of cross-contamination of dust and particles. All concrete work on the south side must be finished first before membranes can be applied.
- 6) When will single-color coat paint jobs for balconies with patchwork colors be available? We hope to have this done in-house for \$300 or less per balcony to be charged to individual unit owners who opt for this solution.
- 7) I have a puddle on the balcony by the inside wall. *Unfortunately, low spots are not in the scope of this work contract.*
- 8) I was told that noisy construction work such as drilling would stop at 1pm daily so that the pool could open and air-conditioners could be turned on. This is correct, a letter from the board will go to Golf Construction concerning this and any other contract violations.

didates Night format be changed to include a 20-30 minute formal question-and-answer session for those candidates who volunteer to participate.

3) Architecture & Aesthetics—Larry Creter

Still planning to have the garage waiting room conform to the lobby look. The garage desk area and carpet will be refurbished. Most of the work is painting, replacing posters, refinishing metal and adding new waiting-area seating.

New hall signs are being put up.

The soft-burnished-brass-type elevator number signs can be inspected on upper levels. Framed fire escape location graphics will be placed above elevator-area ashtrays on each floor. Additional exit and entry signs on each stairwell door will be installed when city specifications are firmed up.

4) ASCO—Sandy Chaet Sharidan Bood plantage

Sheridan Road planters are done and look great. The planted area at the east end of Glenlake is filling in. Bicycle riders are being stopped on Sheridan sidewalks and fined \$250.

5) Garage—Martina Molins

9 yes votes and 9 no votes were returned on questionnaires concerning tandem parking for 2nd cars. We have moved single tandems up to the 3rd floor and are using the open 2nd floor tandem spaces for valet parking. The tandem project will be tabled until the garage repair work is completed.

6) Communications—Janice Krzesinski

New Dialogue guidelines and policies regarding article and advertisement submission were submitted to the board by the editor and approved as modified.

The east side is done, and staging is down. A-tier residents must move balcony items from the south to the east side. B-tier balconies are ready for normal use. Breakout work is almost done. The citymandated 4-year critical inspections will be done on the east, south, and west sides this year. Balcony painting will be done inhouse this summer.

 The engineering will be done this year, the work next year.

- **4)** Roof replacement status Bids are being sought.

With that the lady finally moved the packages, and Marvin sat down to a standing ovation from the other passengers on the bus.

At their last meeting, the Pet Committee discussed several issues, including dog run maintenance. Our staff deodorizes and hoses the dog run down regularly except in freezing weather,



and new gravel is added as needed. It was suggested that the gravel needs to be raked regularly to keep it evenly distributed in the dog run.

During a discussion of dog etiquette, it was suggested that dog owners should be reminded to keep their pets on a short leash to avoid accidents in the atrium and other common areas. Also, please do not use the atrium, ashtrays, fences, driveway or the parkway grass as an alternative dog run. If your pet has an accident in the elevator or in another common area, either clean it yourself or contact the doorman at once for action.

Dog owners should use the passenger elevators **only** when the freight elevator is unavailable. The freight elevator is not intended for regular passenger use, only for pets, laundry, carts and large objects.

The committee reminds all residents who have not registered their pets to do so immediately in the management office.

Four persons from Malibu East joined the 12,000 bikers who participated in Mayor Daley's Bike the Drive, Sunday June 9. Residents Larry Creter, Bill Brock and Jo Gayle, and Joan Burke from our management office, decked out in spandex and helmets, were thrilled to have this first-time opportunity to navigate miles of lakeshore and city streets free from exhaust fumes and the dangerous proximity of autos.

From 5:30 to 9:30am Lake Shore Drive was a biker's dream as Chicago Police Dept. officers and volunteers from the Chicagoland Bicycle Federation kept the Drive free of automobiles.

The multi-lane "bike" path stretched from 57th Street in the south to Hollywood Avenue in the north. The official "turnaround" was at Bryn Mawr, but many die-hard bikers biked the entire drive by turning around at Hollywood and Sheridan Road. The Bryn Mawr turnaround was provisioned with water, fruit and portable toilets, and an emergency bike repair station. The underpass at Bryn Mawr was so packed with bikers crawling slowly to the relief point that many scrambled up and down the embankments around the Drive to evade the bottleneck. It was here that I spotted Joan from our office. She said she had had so much fun that she was going to do the course again. All of the bikers interviewed were hoping that this would become an annual event.

Years of Park District neglect of playlot spurs community action

The Berger Park Advisory Council (BPAC) met 10am Tuesday, June 4 in the lakeside 96-year-old mansion at 6205 N. Sheridan Road. The dark oakpaneled meeting room in the mansion built for long ago Chicago Commissioner of Works Joseph Downey was the scene of community anger and incomprehension of Park District stonewalling on years of promises to rehabilitate the popular playlot at Berger Park.

Berger Park is unique within the park system with its prairie-style mansion fieldhouse, its lakefront location in the Sheridan Road "condo canyon" and its upscale enlightened curriculum that draws children and adults from distant Chicago and Evanston neighborhoods.

The mansion at 6205, which serves as park headquarters, and the neighboring mansion at 6219, which houses the North Lakeside Cultural Center, were destined in the early 1980s for the wrecking ball and the development of more high-rises that would have added to the already dense population of the area. Community action spurred by the Association of Sheridan Road Condominiums Organization (ASCO), the Edgewater Community Council (ECC) and an outpouring of community support saved the priceless lakefront property and led to its purchase by the Chicago Park District (CPD). Although one

of the three original mansions was not salvageable, the two remaining mansions and their two coach houses were lovingly restored to their early century elegance. The mansions with their many rooms are the scene of not only upscale educational classes in the arts, music and drama, but also the setting of Shakespeare plays, opera performances and the meeting point for many local organizations. One of the coach houses has been transformed into a seasonal restaurant with an extraordinary lake view, the other with its high ceiling serves as classroom, gym and auditorium.

A lakeside playlot was built in 1988 north of the two mansions. It is the only play area in this community, and its meager set of playground equipment is always overcrowded by the throngs of local children. Although it shows many indications of neglect and disrepair, other than new swings, it has not been improved or renovated since it was built. The obsolete wooden structure, that serves as a play area, is splintering and dangerous, and a source of many cuts to the children who play there. A low wooden wall that surrounds the playlot has also deteriorated, and the wood chip fill that is supposed to protect the children is woefully inadequate and another source of children's injuries. The CPD has not only neglected this playlot but has reneged on years of promises, claiming budget shortfalls. The CPD had even rejected requests for park benches until BPAC fund-raising efforts resulted in the installation of seven park benches. The CPD belatedly Berger Park playlot 6205 N. Sheridan

offered matching funds for future park bench purchases.

Berger Park's situation is further hindered by the gerrymandered boundaries of Ald. Joe Moore's 49th Ward that encircles the finger of land that the park lies on but excludes Granville Avenue, both sides of which now lie in Mary Ann Smith's 48th Ward.

Years of letters to the supervisors of the Chicago Park District, Mayor Daley, both aldermen and other dignitaries have always met with promises but no action. Recently, letters to those offices have been blatantly ignored. Years of neglect, broken promises and the unresponsiveness of officials have now provoked the community to more extreme measures.

Invitations to this Advisory Council meeting were extended to all of the local organizations, schools and politicians, and commitments were received from many. Unfortunately attendance was poor due to unusually severe storm conditions the day of the meeting. However, a consensus was reached, by those present, that the time had come to prepare and circulate a petition to amass the enthusiastic support of this community that had in the past been instrumental in saving this park. The petition will outline and make clear the years of neglect that Berger Park has been subjected to by the leaders of the C.P.D. and demand that restitution be provided in the form of a new playlot that would serve the needs of the children of this community in a safe and wholesome manner.

Restaurant review

A family runs this 20-year-old establishment with a mother who is classically trained in Paris, France, at the Cordon Bleu. The father manages the restaurant and makes sure



everyone is happy. Their children help out, too. They are in college but find time to work in the family business.



A majority of the clientele comes from the Edgewater Beach Apartments. It is so convenient and the food is so good. One of the problems is that most of the rest of the neighborhood is not aware of the Edgewater Beach Café. Exterior signage is next to nothing, and I have never seen advertising about it. Friends of ours from the building and others who live across the street told us how good it was, and we joined them for dinner. It was so delicious that we made sure we returned several times and brought others to sample the menu. I feel strongly that more people should try this wonderful French/American cuisine. When you are ready for an elegant night out, the Edgewater Beach Café can offer you that - with reasonable prices.

A typical dinner menu offers wonderful classic appetizers that include shrimp cocktail, escargot bourguignonne, wonderful shrimp de jonghe, and spinach salad with hot-bacon dressing. There are even more starters, and also daily specials that increase your choices and make it harder than ever to pick. The entrée selections are mainly from the classical school of cuisine. Think of

this, will you pick tournedos of beef with green peppercorn sauce or filet mignon marchand de vin? Maybe the New York strip steak or broiled whitefish? The house specialties are grilled shrimps with burgundy and mustard sauce, and roast duck with apple brandy sauce. 18. No smoking rule

A read-through of our Malibu East Rules and Regulations will find many instances of "no smoking" here and there throughout the



building. In March of 2000, the Malibu East board of directors in concurrence with contemporary mores and health considerations formally instituted a building-wide "no smoking" rule with the two exceptions stated below. This rule extends to the Captain's Walk.

We have installed ashtrays at the atrium lobby entrance and the mall entrance for those entering and for those who step outside for a smoking break. Please use them, do not litter our front door with cigarette butts. Ashtrays are still available at the elevator entrances as a safety measure for those smokers who may forget and leave their units with a lit cigarette.

Please remember that the stairwells or garage parking areas are not a "quick smoke" area for you or your guests. Be considerate of other residents and our maintenance staff, who must continuously police and clean these areas.

XXXI. NO SMOKING RULE

The No Smoking Rule is as follows:

"Smoking is not permitted inside the Malibu East building except in individual units, on individual balconies, or during private parties in the Windjammer Room, at the discretion of the host. In addition, smoking is prohibited in the pool enclosure."




